# SPECIAL MEETING BADEN BOROUGH COUNCIL FEBRUARY 4, 2014

### **VISITORS**

Joe Kostial addressed his concern about the purchase of the gas station being a waste of money. He expressed the need for funding to repair roads and gave Franklin Avenue as an example.

## **COUNCIL DISCUSSION**

Michael Stuban addressed the situation regarding 330 State Street. This included the property being condemned and cited. A hearing was held with the Magistrate and the property owner was found guilty so filed an appeal. At the recent hearing the property owner asked that all taxes be dropped so that the property may be sold. There was an interested buyer (Gaudino) however he rescinded his offer. The judge offered (asked) if Baden had an interest in the property which prompted the meeting this evening. The next hearing date is scheduled for February 20<sup>th</sup>.

Bob Besong stated that he is against purchasing the property because of the cost and the need for money to repair other things in Baden.

Conversation took place regarding what would be done with the property? No decision was determined however comments included tearing it down or fixing it up. Kim Villella asked what would happen if we didn't buy the property. The main concern was that the property is an eye sore located in a prime area of town and if we wait until the property goes up for judicial sale we will be no further along with fixing the problem because the property is still an eye sore and we will continue to be spending money on legal fees. By purchasing the property the borough will have control over making sure that the property is cleaned up (either through repair or demolition).

Mayor Gagliardi commented that he agrees that this is prime property but determining the use of the property is essential. He noted that the property had 25 items listed on the citation and we don't want to be stuck with a white elephant. Michael Stuban noted that the main item that must be addressed would be repair of the roof. President Montell commented that the other cited items are fixable such as removing the facade of the building and she also noted that some things can be recycled.

Further discussion took place as to possible uses of the property. President Montell noted that this decision can't be determined at this time. We must first determine if it is feasible to purchase the property.
