Purchase a new salt spreader for the GMC 4500 from Sabre Equipment for \$6,974 **(Motion)**

- **Altitude Valve for Harmony Tank Pit**

Altitude GA Valve needs repaired at the Harmony Tank Pit. The cost for the repair kit and labor from Cla-Val Services is \$2,013. **(Motion)**

- **Ductless Heating & Cooling System for Harmony Water Tank Chlorination Building**
The building that houses the chlorination equipment needs a regulated temperature to maintain the chlorine strength. The price for a ductless heating and cooling system installed by Albert's is \$5,765. **(Motion)**
